臺灣大學經濟學系國際事務委員會將於第一階段書面審查後,與申請同學進行第二階段面談,之後將於三月底選出推薦名單。獲推薦之同學須於四、五月份期間準備赴香港就讀之文件(申請學生護照程序請見

國立臺灣大學經濟學系與香港城市大學經濟及金融系雙學士計畫協議書

國立臺灣大學經濟學系(以下簡稱臺大)與香港城市大學經濟及金融系(以下簡稱城大)同意在互惠原則下設立雙學士計畫協議(以下簡稱本計畫)。

- 第一條 國立臺灣大學經濟學系與香港城市大學經濟及金融系為本計畫之專責 行政單位。
- 第二條 符合本協議規定條件之學生以全職學位生身分於接待機構修課,修業期限最長為二學年。學生完成本計畫之規定後,將獲雙方機構頒發之臺灣及香港法律認可之學位。由國立臺灣大學所授予之學位名稱為「經濟學學士」;由香港城市大學所授予之學位名稱為「工商管理學學士(商業經濟)」。
- 第三條 學生之註冊、休學、復學等學籍管理之行政事項,均依接待機構相關 辦法辦理。
- 第四條 學生原則上依下列規定由原屬機構選出。但遇特殊情況者,得以修正:
 - (一) 應至少在原屬機構修讀滿一年之全日制課程。
 - (二) 應學業成績優良, GPA 達 3.0 或以上。
 - (三) 應符合原屬學校及接待學校之所有入學要求及其他規定。
- 第五條 原屬機構所提名之學生原則上為接待機構所接受。但接待機構仍保留 審查學生入學資格之權利,及給予入學許可之最後決定權。接待機構 應提供入學許可通知函及其他必要文件以利學生順利至接待機構就 讀。
- 第六條 於接待機構修業期間,雙方學系之學生均應符合下列所有課程及學分 規定,始核發其學士學位。

接待學校修業期間之課程及學分規定:

- (一) 赴城大取得學士學位之臺大學生:
 - 1. 取得城大學位總學分數為72學分,每學期至多得修習18學分。
 - 2. 若需每學期修習超過18學分,應獲得城大之許可。
 - 3. 須符合附件一之其他課程及學分規定。
- (二) 取得臺大學士學位之城大學生:
 - 1. 取得臺大學位總學分數為 63 學分,每學期至多得修習 18 學分。
 - 2. 須符合附件二之其他課程及學分規定。
- 第七條 學生於修業期間結束後,如未能完成取得學位之全數規定,得視為交 換學生。

- 第八條 學生將由國立臺灣大學社會科學院院長出具英文能力已達城大對修業學生訂定水準之證明,學生亦將提供英文能力測驗成績(TOEFL、IELTS等)。
- 第九條 参加本計畫之學生應在原屬機構註冊及負擔原屬學校要求之所有學雜費,以參與計畫,毋須繳交接待學校之學雜費、申請費及學分費。參加本計畫若需申請費,依原屬學系之規定繳交給原屬學系。參加本計畫之香港城市大學學生得獲國立臺灣大學提供之獎學金。但獎學金得依學校規定有所更動。香港城市大學將提供特定之國立臺灣大學學生住宿補助及/或獎學金。
- 第十條 接待機構於學生修業期間內每一學期結束後,應將學生之正式成績單 寄與原屬機構。學生在接待機構所修習之學分,得依據原屬機構相關 規定及程序予以採計。
- 第十一條 於接待機構修業期間結束後,如學生已完成接待機構所有相關學位規 定,接待機構應將學生之正式成績單寄與原屬機構。學生已符合其原 屬機構畢業資格後,接待機構始得授與學生正式學位證書。
- 第十二條 本協議下之學生應遵守接待機構之規定,並享有與接待機構其他學生相同之權利。
- 第十三條 雙方機構有權在任何時間遣退於學業或個人操守違反規定之學生。遣退任一學生均不影響本協議下其他學生之約定。
- 第十四條 雙方機構應盡力協助本協議下之學生尋找適合之住宿,並提供符合其 規範之諮詢及援助。學生應自行負責投保醫療及/或非醫療保險並取得 規定之最低保額以上之額度,且應自行支付超出原投保保額所衍生之 相關費用;且應自行負擔旅費、住宿費、生活費、醫療費、書籍費及 其他個人支出費用。
- 第十五條 接待機構應針對註冊、校園生活、文化調適、健康、語言及當地風俗 習慣等可能問題,提供學生適當協助或指導。
- 第十六條 協議期間內雙方機構每年可各接受五名以內之學士班學生。學生人數 在雙方同意下得予修正。雙方於五年期間內之雙學位學生總數應達平 衡。
- 第十七條 接待機構應依法核發學生於申辦簽證時所需文件。但學生仍須自行負 責簽證相關事宜,並及時取得簽證。

第十八條 本計畫之相關其他事宜,應依兩校相關辦法由兩系進一步協議。

第十九條 本協議自簽署日起生效,若有一方欲中止或修改本協議,應於十二個 月前以書面通知對方。

第廿條 本協議以中文及英文擬定及簽署。

AGREEMENT OF JOINT BACHELOR'S PROGRAM

BETWEEN

DEPARTMENT OF ECONOMICS AND FINANCE AT CITY UNIVERSITY OF HONG KONG

AND

DEPARTMENT OF ECONOMICS AT NATIONAL TAIWAN UNIVERSITY

Department of Economics and Finance at City University of Hong Kong (CityU) and Department of Economics at National Taiwan University (NTU) hereby agree that the following changes will be superseded the previous version and effective from Semester A 2015/16.

For NTU students in CityU

- "CB2200 Business Statistics" is a new course from the College of Business that NTU students will take in Year 2;
- 2. "CB2201" has been retitled to "Operations Management";
- 3. "Foreign Language English (I)" can be used to fulfill the requirement of "GE1401 University English" in CityU. If a student is exempted from taking "Foreign Language English (I)", s/he has to take the "GE1401 University English" in CityU. All NTU students need to take "GE2402 English for Business Communication" in CityU, which can be transferred to the General Elective in NTU in Year 4;
- 4. All NTU students need to take "GE1501 Chinese Civilisation History and Philosophy" in CityU, which can be transferred to the General Elective in NTU in Year 4.

For CityU students in NTU

 CityU student will take "Statistics and Econometrics with Recitation (I)" in NTU to fulfill the requirement of "CB2200 Business Statistics"; 2.CityU student will take "Cost and Managerial Accounting (I)" in NTU to fulfill the requirement of "CB2101 Introduction to Managerial Accounting".

For both NTU and CityU students

- "Calculus (b) (I)" in NTU is deemed equivalent to "MA1006 Calculus and Linear Algebra for Business", which credit transfer will be granted by Mathematics department in CityU;
- The total number of Gateway Education courses in CityU is reduced from 7 courses to 4 courses, and the remaining 3 courses will be shown as College Electives, these College Electives courses are used to fulfill the Liberal Education requirements in NTU;
- 3. "國文領域下" in NTU can be used to fulfil 3CUs of GE Distributional Area 1: Arts and Humanities Requirements in CityU.

Any further revision or modification is subject to mutual consent given in writing. In addition to the above, all other terms and condition will follow the agreement signed on 20 February 2014.
